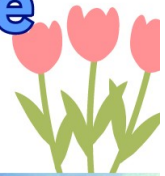

**COUNTDOWN TO COMPLIANCE BEGINS:
TIME'S UP! NEW YORK STATE DFS
CYBER CHANGES ARE FINAL!**

Revisions to the New York State Department of Financial Services (NYSDFS) Part 500 cybersecurity regulation are now final.

With this revision, NYSDFS is emphasizing compliance and governance from several angles – from the top down, by requiring CEO and CISO signoff based on data and documentation.

As of December 1, 2023, not only must the highest ranking executive (usually, and hereafter, the CEO) now sign off on compliance with the regulation, but this certification must now be based on data and documentation sufficient to accurately determine and demonstrate material compliance (described further below), including any reliance on third parties and affiliates to meet the requirements.

Because this change takes effect on December 1, 2023, it will be in place in time to lift the bar for this year's certification, due for submission by **April 15, 2024**.
